Adversely affected many sectors of economy worldwide

□ Companies and operations, including production units closing down

Caused severe global economic crisis


Disruptions of steady supply of finished goods and raw materials as many sources went into total lockdowns



- China: Largest producers of Active Pharmaceutical Ingredients (medicine raw materials) in the World; Major producers of Medical Supplies
- Restrictions of exports of raw materials (China and India) affected manufacturing in other countries
- Lockdowns: Airlines and Shipping companies temporarily or completely halted shipment of goods
- Impacted negatively on world-wide trade and supply chains.

# **OUT OF STOCK**

Panic-buying and Stock-piling at Health Facilities level

Pressure on supply chain as demand outstripped supply

- □ Non Traditional Clients: Airlines, Defence Agencies, Churches
- Capacity of Suppliers: Not able to meet demand since they were dependent on the same sources that were experiencing lockdowns and shutdowns
- □ Market Failure: High demands and limited supply
  - "Seller's market" new terms and conditions for buyers new payment terms upfront payments, excessive mark-ups
- Delayed Deliveries

# **EFFECT ON COMMODITIES**

### Erratic Price Changes for Healthcare Products

- Supply chain disruptions led to increase in prices
- Many suppliers could not maintain tender prices
- Prices for Personal Protective Equipment (PPEs) e.g. Masks and Shields went up more than 2000%
- Paracetamols went up more than 110%
- Quality of Commodities Compromised
  - Mushrooming of suppliers; Lack of proper regulation substandard and fake commodities were in circulation
  - □ Quality of some products e.g. masks and sanitizers got compromised


# Stockpiling of health products and technologies experienced in first quarter of 2020

- Reduced Patient Numbers: Fear of Contracting Virus
  - Reduced demand for health commodities by health facilities

EFFECT ON COMMODITIES MOVEMENT

- **Distorted** consumption pattern and data
- Reduced Demand/Slow Movement of Stock

53% of Target Sales in May 2020 in MEDS Supply Chain
57% of Stock items performed below anticipated movement





- Increase Buffer Stock Levels
- Increased Supplier Base
- Multiple Suppliers for Products
- Virtual Pre-qualification of Suppliers/Manufacturers
- Suspended annual tender due to prices volatility and anticipated inflated prices – extended tenders instead
- Use of Technology Virtual Suppliers Conferences



As a way forward, Supply Chains will not go back to previous status; measures adopted may become the new normal:

- Increased Demand for Medical Equipment: As health facilities deal with emergencies equip wards and isolation units
  - Beds, oxygen concentrators, pulse oximeters, nebulizers and ventilators
- Local manufacturing: Opening up local manufacturing plants by Drug Supply Organisations/Supply Chains
  Alcohol-based hand sanitizers, Oxygen

# **EMERGING OPPORTUNITIES 2**

- Diversification of Stock Items: Personal Protective Equipment (PPEs), Hand sanitizers, Surgical Masks, Gowning
- New Services: Introducing new testing services for Covid-19 related products at Quality Control Laboratories
- Partnerships: With Governments, Donors, Supply Chains -Distribution, test locally-manufactured products (alcohol-based hand sanitizers) identifying substandard and counterfeit products
- Embracing Technology: Online meeting/conferences/webinars, purchase orders
